We fund low cost and free spay and neuter clinics in low-income areas provide training and behavioral coaching for all dogs and their human companions to keep dogs at home with loving families and out of shelters. This includes MHCR and non-MHCR dogs through our grant program. We provide underfunded rural shelters with vaccines and supplies to keep their dog population healthy while waiting for adoption or rescue. We offer an emergency medical grant program for dog owners whose dog is experiencing a medical emergency, but they cannot afford the high cost of treatment. Most owners in this situation must choose euthanasia or surrender to a rescue/shelter. We provide financial assistance to smaller rescues and shelters in underserved areas.
